5. Cancellation/update of EFC tournaments

Since the CC Cup in sabre initially planned for Barcelona was moved by Spanish Fencing Federation to Segovia, Jacek reminds the Bureau members about creation of the working group in October 2023 to update the EFC rules concerning cancellation/updating EFC tournaments.

6. Solidarity programme - follow up

Jacek informs the Bureau members about 3 courses to be organised:

- 1. Sabre course in Slovenia. Hungarian Fencing Federation will provide coaches. Initial date middle of December.
- 2. Safeguarding course in Denmark. British Fencing Federation to provide mentors. Course to be confirmed by Hilary Philbin during FIE Congress in Tashkent. Course is to be held in 2025.
- 3. Safeguarding course in North Macedonia. British Fencing Federation to provide mentors. Course to be confirmed by Hilary Philbin during FIE Congress in Tashkent. Course is to be held in 2025.

7. Fencing For Everyone – additional call for organisers

Jacek informes that within the set deadline only one application was submitted by Bulgarian Fencing Federation (Sofia). They want to host a tournament in epee and in sabre. The Bureau decides to award the organisation and inform all MF-s on short notice.

8. EFC meeting in Tashkent (2024-11-29) - update

Jacek updates the Bureau members about the preparations to the EFC meeting in Tashkent planned on October 29, 2024. The hotel has forwarded request to the local organizer and the EFC waits for the offer from Fencing Federation of Uzbekistan. The Bureau decided to give a heads up to all MF-s about the organisation of the meeting to allow MF-s to make flight arrangements accordingly.

9. Comex meeting in Munich (2024-11-23) - update

Jacek updates the Bureau members about the progress of the preparations to the Comex meeting in Munich.

10. Wheelchair fencing in the EFC

Jacek asks the Bureau members to consider a possibility to extend EFC activities for wheelchair fencing.

Pascal informs that in the past there FIE World Championships in 2010 in Paris and 2013 in Budapest as well as the European Championships 2014 in Strasbourg were jointly organised with IWAS It always showed to be a huge logistical challenge and collaboration with IWAS was not always synchronized leading to tensions. He however stresses the importance of inclusion and concludes that we should stay open to potential opportunities.

11. Set up a date of the online Comex meeting

Pascal proposes to schedule a Comex meeting for 2024-10-25 at 19:00 CET and an additional Bureau meeting on 2024-10-16 at 20:00 CET to prepare the online Comex meeting. Jacek was tasked to inform the Comex members.

12. Various

Since some members of the executive committee are new Pascal elaborated a quick guide for the members which contains references to the EFC and FIE rulebooks/statutes. Etienne explains that in the absence of provisions in the EFC-rulebooks the FIE-rules take over.

The Bureau makes some amendments to the document and asks Jacek to forward it to the members of the executive committee.

Pascal presents another document for the bureau members to reflect on. The document is about working procedures and is in line with the president's electoral promise to improve good governance. Once the document is completed it will be published.
