8. Review proposals to the Congress

Two Federations submit proposals to the EFC Congress: HUN and ITA.

Etienne took the floor and presented opinion of the Legal Commission:

Following is the opinion of the Legal Commission on the proposals submitted by Member Federations on the occasion of the EFC Ordinary Congress 2024. The Commission has focused on legal aspects only and leaves political or other considerations to COMEX and Congress.

Proposals of the Italian Fencing Federation:

- 1. The proposal aims to modify the EFC Statutes with an added provision to the Mission and Goals section to promote and develop the practice and culture of Historical Fencing European Martial Arts. The Legal Commission has no opinion on this first proposal.
- 2. The proposal aims to create a Commission dedicated to the research for opportunities of fundings and work for the implementation.... funds covered by the European Commission in favour of European and Third Countries. The Legal Commission is in favour of the idea that is put forward through this proposal. However, since the proposal has been submitted without formulating the definition of that Commission in article 13 of our Internal Rules, the proposal is incomplete and should therefore be rejected in its current form. Congress could ask COMEX to formulate the correct text covering the proposal to be included in the Internal Rules to come into effect at the 2025 Congress. In order to start the work that is being proposed to be carried out after the 2024 Congress, the Legal Commission proposes the form a Working Group with the same mandate until such time a complete proposal for a Commission can be submitted and the Commission can be established.

Proposals of the Hungarian Fencing Federation:

- 1. The proposal aims to add a provision to introduce the title of Honorary President of the EFC. The Legal Commission has the following:
- a) The rationale states: "For extraordinary and excellent merits to the EFC and long and loyal service to European fencing,...". For this purpose the EFC already has created the Honorary Membership. A Honorary Presidency is therefore superfluous. The granting of such title would generate confusion with the existing the Honorary Membership and possibly devaluate the appreciation Congress has given our Honorary Members for their lifelong service.
- b) b. The FIE does not employ the title of Honorary President in her regulations. The EFC, with adopting this title would go against the FIE regulations.

c) c. The title of Honorary President of the EFC is proposed to be recommended for either a former President or former COMEX member. Proposing the title of Honorary President to a COMEX member generates confusion and the Legal Commission does not understand the rationale for this proposal.

Consequently, the Legal Commission advises against this proposal.

- 2. The proposal concerning the nomination of presidents to various Commissions: they could be chosen from the proposed list of candidates for Commissions instead of appointed from the group of COMEX members.
 - a) The Legal Commission notes that a rationale for this proposal is missing. If the rationale were the following: the Presidents of the Commission must have the same requirements and qualifications as the candidates of the Commissions, then the Legal Commission would disagree. The President of the Commission chairs the Commission and thus does not need to have the same qualifications as the Commission Members and reports to the COMEX (Internal Rules 12.3).
 - b) The proposal states that the Commission Presidents are to be chosen from the "proposed" Commission Members. This could include candidates that were for some probably good reason not approved as Commission Members. The Legal Commission considers this undesirable.
 - c) It is important to maintain our democratic principles. Congress elects COMEX members, COMEX members lead Commissions. If Presidents of Commissions are to be chosen from outside the group of COMEX members, the will of our Member Federations in electing who will be in leading functions in COMEX or who will be leading Commissions will be bypassed and the strong link between COMEX and Commissions will be broken.

Concluding, the Legal Commission advises against this proposal.

- 3. This proposal aims to introduce a European Hall of Fame of the EFC. The Legal Commission has no opinion about this proposal.
- 4. The Legal Commission has no opinion about the proposal to introduce the European Championships in the U14 category.
