# Report about EFC Cadets Circuit 2013 - 2014.

Running of the project for Cadets seems be stabilised since its beginning stage. At the present the most actual issue became the intervention of the FIE putting forward new principles of FIE Calendar where his Secretary General, Mr. Pietruszka, tried also harmonise EFC CC Calendar with that of the FIE in a view that FIE JWC and EFC CC are interconnected by participation of best cadets in juniors World Cup competitions. Respecting the principle that no cadets competition at the level of the EFC CC can be organised at the same weekend where JWC in the same weapon is to be held, the EFC CC Calendar for 2014-2015 has some weakness because there was no possibility to apply mentioned principle together with the principle of creating minimum 2 weeks between competitions of the same weapon. It is foreseen some discussion between FIE SC and EFC Technical Director during Championships in Plovdiv 2014, which should lead to solving that imperfection.

#### 1) Main issues

- a) Formula of competitions: there are no complaints concerning *status quo* therefore can be stated that it suits needs and practice of participating federations.
- **b) Teams**: the team events continue their progress and current state seems give satisfaction to interested federations without modifications.
- c) Rankings: for the season 2013-2014 we extended the use of coefficients bringing some improved differentiation between different competition's level from the view of their level of quality.

**Men's foil**: Florina 1,5 Pisa 3,0 - all others 4,0

Women's sabre: Tbilisi 1,0 Moscow 1,5 London, Sofia, Konin 2,0 – Meylan,

Moedling 3,0 - Godollo, Goeppingen 4,0

Men's sabre: Tbilisi 1,0 Moscow 1,5 Sofia, Konin, Meylan, Modling 3,0 Godollo,

Goeppingen, London 4,0

New scale of multiplicators did not influence so much foil and epee but it is more visible in sabres where it creates 4-5 groups of competitions.

Here should be mentioned that tournament in Tbilisi did not met criteria adopted in Budapest 2013. However, EFC Executive Committee agreed to offer for that organiser an exception for 2013-2014 season as a new organiser in the Circuit. For next season also this tournament has to fulfil criteria otherwise no point will be accorded to the participants of that events.

**Proposal:** for the future all new organisers of competition of the Circuit for the first time (1x only) are exempt of fulfilment of criteria. Thus no exception will be awarded for organisers of competitions of the Circuit afterwards.

- **d) Organisations of competitions:** The administrator of the Circuit did not receive any comment or complaint about that issue in general. The only criticism was expressed concerning refereeing of competitions, especially in conventional weapons. (See following paragraph.)
- e) Referees. There are continuing complaints about level of referees provided by delegations as well as provided by the organisers. In extreme situation there were only referees from two concerned teams having both fencers in final stages of competitions. The EFC is starting to develop a project for creation of EFC referee license working with following principles:
  - Main task holder is EFC Commission of referees (further RC)
  - First step will be analyse in detail of statistical data about activity of referees available from all competitions of the Circuit
  - Next step would be set up of the list with referees who officiated in 2013-2014 season at 54 competitions of the Circuit
  - RC will prepare general policy considering the possibility to introduce assignment of referees to EFC CC competitions replacing that way current obligation of quota of referees to be provided by delegations participating at competitions (The EFC received already suggestions in this regard from Italian Federation)
  - Another component of the project would be establishment of "supervisor" delegate assigned by EFC Commission of referees in charge to observe referees officiating at EFC CC competitions, making appropriate report allowing evaluation of the referees and upon that evaluation the list of "EFC Referees" could be created
  - EFC Executive Committee will adopt most suitable solution also from the view of the way how the financing of the project could be ensured without charging national federations
  - All mentioned steps and some possible other elements should be done during current 2014 2015 season and in next season pilot project should be put in place.
  - The EFC would like to propose to the FIE the use of outputs of that project in a way where only candidates for FIE exams could be proposed by national federation using the list of "EFC referees" giving a guarantee that those candidates are having real international experience from EFC CC.
- f) Inscriptions for competitions: continuing registration and inscription system at EFC web site was used. Updating of rankings and entering of rankings into EFC database, which is generating XML files for competitions was carried out fully automatically. However, the organisers should improve the treatment work of results strictly respecting following rules:
  - All xml results files must be sent immediately after competitions to EFF TD regardless if automatic uploading on EFC web site was successful or not
  - Detailed results in PDF format should strictly follow the rules published in this regard on EFC web site, which are as follows:

For individual competitions the order of files should be:

Fencers (including birth date or year of birth) ordered by country ("Structured menu") – no alphabetic, not by ranking!, those can be added as optional Formula of competition

Poules with results

Ranking after poules

Tables of Direct elimination phase

Final ranking of competition including date of birth or at least year of birth of athletes Activity of referees

For teams events: (Also from those competitions xml files are to be sent to EFC TD)

Fencers in teams with their initial rank

Teams ordered by initial seeding for competition

Tables of Direct elimination with results

Final ranking of teams

Activity of referees

All details of matches
